1. This permit or bonafide permit number must be in the possession of the operator of the a/n vehicle.
2. All sections under the Alberta Motor Transport Act and its Regulations must be complied with.
3. The permit holder shall move the vehicle and load described herein entirely at their own risk.
4. Under no circumstances is a permit holder to remove any signs or structures along the route without first obtaining permission from the Medicine Hat Police Service and/or Public Works.
5. In the case of mechanical breakdown or adverse conditions, the permit holder shall not abandon the vehicle or load on the roadway but shall forthwith arrange to remove the vehicle & load from the roadway.
6. If during the movement of a vehicle and/or load covered under this permit, a hazard has been created to the public by any cause, including but not limited to, a vehicle or loaded vehicle becoming stationary on the roadway or damage done to bridges, culverts or other structures, the permit holder shall notify the Medicine Hat Police Service forthwith and shall provide all possible assistance to the public using the highway in order to avert injury to persons or property.
7. Any deviation from the conditions of this permit by the permit holder shall be sufficient cause to revoke or cancel this permit and to withhold further issuance of permits to the permit holder.
8. Any person who violates the provisions contained in this permit is guilty of an offence under the City of Medicine Hat Traffic Bylaw #2434.
9. Escort fee, no charge if self escorted.

**Police Escort Fees: \$110/hour per police vehicle (minimum charge = 2 police vehicles @ 3 hours)**

**Total for a minimum of 3 hours with 2 police vehicles = \$660.00**

**NOTE:** If the escort is longer than 3 hours the company will be charged an additional \$110.00/ hour per police vehicle. If the escort requires more than 2 police vehicles the company will be charged the minimum 3 hours for each additional police vehicle. (eg. 3 police vehicles @ 3 hours = \$990.00)
